Sustainable Development Goal 16: Promote peaceful and inclusive societies for sustainable development, provide access to justice for all, and build effective, accountable and inclusive institutions at all levels.

The United Nations' most recent progress report on its Sustainable Development Goals for 2030 maintains that, "conflict, insecurity, weak institutions and limited access to justice" remain threats to sustainable development. These threats have only been amplified during the COVID-19 pandemic in 2020, further jeopardizing the world's admittedly slow progress toward achieving "peaceful and inclusive" societies.

While Gallup's latest global surveys on people's perceptions of their own security were collected in 2019, before the pandemic,

the results provide a baseline for how the world will respond to the challenges that have surfaced during the ensuing crises, including those related to law enforcement in the United States and elsewhere.

The results show that, ahead of these challenges, there is much room to grow. None of the four security metrics that Gallup asks about, including the proportion of people who feel safe walking alone around the area where they live — one of the indicators of Goal 16 — has changed much, if at all, in the past several years.

Gallup's Law and Order Index uses four questions to gauge people's sense of personal security and their personal experiences with crime and law enforcement.

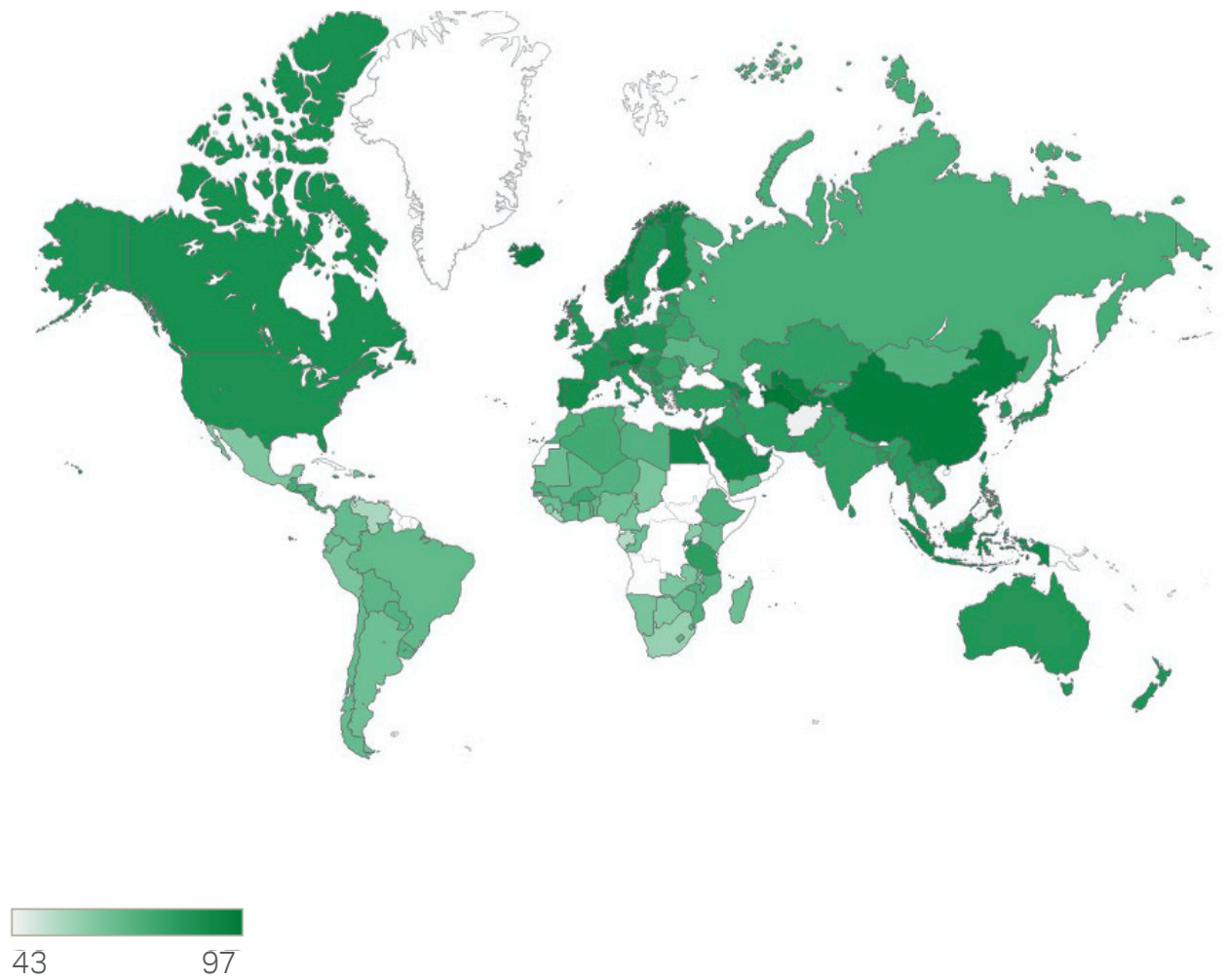

- In the city or area where you live, do you have confidence in the local police force?
- Do you feel safe walking alone at night in the city or area where you live?
- Within the last 12 months, have you had money or property stolen from you or another household member?
- Within the past 12 months, have you been assaulted or mugged?

The *2020 Global Law and Order* report presents the results from Gallup's latest measurements of people's answers to these questions, based on interviews with nearly 175,000 adults in 144 countries and areas in 2019.

Most of the World Remains Confident in Police, Feels Secure

Nearly seven in 10 people worldwide said in 2019 that they feel safe walking alone at night where they live (69%) and have confidence in their local police (69%). About one in eight (12%) said they had property stolen from them or another household member in the past year, and 6% said they were assaulted or mugged. These numbers remained largely unchanged from 2018.

Gallup compiles the “positive” responses to these four questions into a Law and Order Index score for each country. The higher the score, the higher the proportion of the population that reports feeling safe. The index score for the world in 2019 was 82 out of a possible 100 — basically unchanged from scores since 2017. Ninety countries and areas posted index scores lower than the global average.

Countries scoring highest and lowest on the index were also largely the same as in recent years. Scores worldwide ranged from a high of 97 in Singapore — which tops the list nearly every year — to a low of 43 in Afghanistan, which ranked the lowest in the world for the second consecutive year.

As low as Afghanistan’s score was in 2019, it represents an improvement from the record-low score of 38 the previous year, which was one of the deadliest years for Afghan civilians in recent record.

Notably, Afghans did not feel any safer (12%) walking alone at night, nor were they any more confident in their police (24%) in 2019 than in 2018. In fact, no other country posted worse scores on these two measures. However, the country’s overall score improved because Afghans were less likely to have been victims of property crime (40%) in 2019, or to have been assaulted or mugged (22%), than they had been the previous year, when 50% had money or property stolen and 29% had been assaulted.

Latin America, Sub-Saharan Africa Face Security Challenges

As in previous years, people in Latin America and the Caribbean were the least likely among all global regions to feel secure in their communities. However, in 2019, the region scored a 66 on Gallup's Law and Order Index — the region's highest score in recent years — placing it on par with sub-Saharan Africa at 67.

In most regions, the 2019 scores on the Law and Order Index were relatively within the same range as the past several years. However, the score in the region of Latin America and the Caribbean continued to climb, as did the score in East Asia. Overall, in most regions, scores for individual countries also tended to change very little.

Higher security scores in a handful of countries in Latin America and the Caribbean helped raise the region's overall score in 2019. Index scores improved measurably in Bolivia, Brazil, El Salvador, Nicaragua, Uruguay and Venezuela. In these countries, more residents felt safe walking alone at night in their communities and expressed more faith in their local police than they had in several years.



Afghans Still Least Likely in the World to Feel Safe Walking Alone at Night Where They Live

Just 12% of Afghans in 2019 said they feel safe walking alone in their area at night — similar to the 13% who said so in 2018. This ties with the previous record lows claimed by Venezuela in 2015 and 2016, when 14% and 12% of the population, respectively, reported feeling safe in their neighborhoods. Notably, in 2019, more than twice as many Venezuelans (29%) said they felt safe walking alone at night where they live. However, this percentage is still among the lowest in the world.

Except for Afghanistan, the countries in which residents are least likely to say they feel safe walking alone at night are exclusively countries in Latin America and the Caribbean and sub-Saharan Africa. Eight of them also ranked among the least safe in 2018. The exceptions were Lesotho, which was not surveyed in 2018, and Namibia, which narrowly missed making the bottom of the list in 2018.

In most economically developed countries with strong rule of law, the majority of residents say they feel safe walking alone in their areas at night. This response is nearly universal in Singapore, at 97%, and tops 80% in many Western European countries. The same is true for more highly state-controlled countries.

In 2019, the U.S. was only slightly above the global average at 75%, which was statistically unchanged from 72% in 2017 and 2018. This percentage edged up to 78% when Americans were interviewed during the heart of the pandemic lockdown in March through early May 2020. Gallup Panel surveys in June and July 2020 — amid ongoing protests sparked by the killing of George Floyd — found a similar 80% reported feeling safe.

Confidence in Local Police

More than two in three adults worldwide (69%) said in 2018 that they have confidence in their local police. The results varied significantly by region, however, from a low of 49% in Latin America and the Caribbean to nearly double that in Western Europe (83%).

The relatively low average on this measure in Latin America and the Caribbean is not surprising given the region's poor performance on all the Law and Order Index metrics in 2019 and previous years. However, the 49% who were confident in their local police in 2019 is the highest percentage on record for the region in more than decade of Gallup tracking.

With a few exceptions, confidence in the police remained stable or improved across most of Latin America and the Caribbean in 2019. Confidence notably plummeted in typically stable Chile, which experienced some of its worst unrest in decades. Chileans' confidence in their local police dropped from 59% in 2018 to a record-low 44% during protests in which Chilean President Sebastián Piñera later acknowledged the police had committed "abuses."

Methodology

Results are based on telephone and face-to-face interviews with approximately 1,000 adults in each country, aged 15 and older, conducted throughout 2019 in 144 countries and areas. For results based on the total sample of national adults, the margin of sampling error ranged from ± 2.1 percentage points to ± 5.6 percentage points at the 95% confidence level. All reported margins of sampling error include computed design effects for weighting.

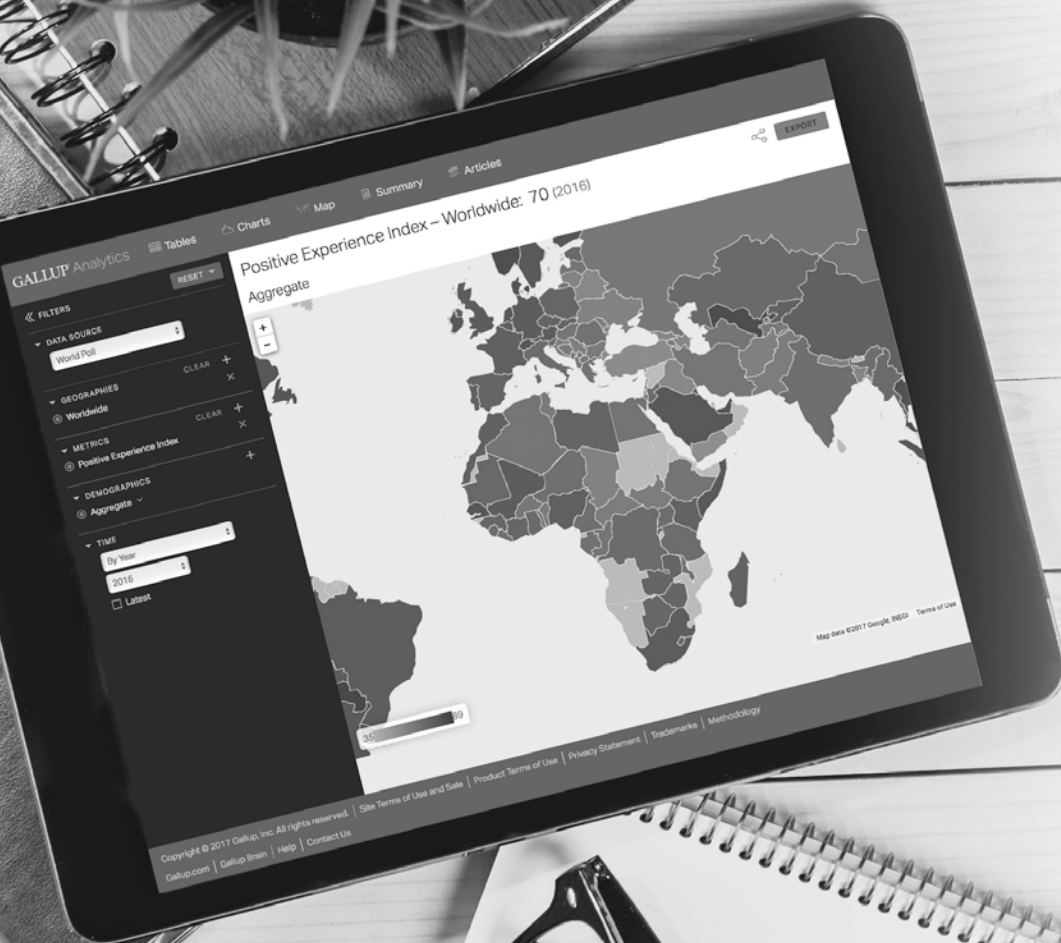
